



Privacy Policy

General

Redstone College, Inc. (dba Alta Colleges) respects the privacy of every individual who visits our web sites, requests information, or responds to our promotions. To better protect your privacy we have provided this notice explaining our online information practices and the choices you can make about the way your information is collected and used. Information you provide to us

Alta Colleges will collect personally identifiable information about you such as your name, address, telephone number, or email address. We will collect additional information such as your social security number, date of birth, ethnicity and emergency contact information when you register for our online admission center. We collect information that you provide to us for the following uses, unless otherwise stated:

- We will use it to contact you and respond to your request for information.
- We may store and process the information to better understand your needs and how we can improve our web site and services.
- We will use this information to create an account for you when you register with our online admission center.
- To provide you access to your online account so that you may register for classes, update information, or receive information that you have requested.
- To send you email notifications as they pertain to your account, site updates, and upcoming events.
- To allow you to apply for a job

Additionally:

- We will not sell, share, rent, or trade your individual information with third parties other than as disclosed within this privacy policy.
- We will maintain the confidentiality of your personal information and it will only be used to support your relationship with Alta Colleges.
- We may disclose your personal information as required by law, such as to comply with a subpoena, or similar legal process, when we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request.
- We may disclose your personal information if Alta Colleges is involved in a merger, acquisition, or sale of all or a portion of its assets, you will be notified via email and/or prominent notice on our Web site of any change in ownership or uses of your personal information, as well as any choices you may have regarding your personal information.
- We may provide your personal information to companies that provide services to help us with our business activities such as sending out email communications on our behalf or offering customer service. These companies are authorized to use your personal information only as necessary to provide these services to us.

If you submit a review:

Access to Personally Identifiable Information

If your personally identifiable information changes, or if you no longer desire our service, you may correct, update or deactivate it by logging into your account if you are a registered student and updating your settings, filling out the request info form again, or by contacting us at information@Redstone.edu.

We will retain your information for as long as needed to provide you services. If you wish to cancel your account or request that we no longer use your information to provide you services contact us at information@Redstone.edu. We will retain and use your information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements.

Testimonials/Videos

We post graduate testimonials and videos on our website which contain personally identifiable information. We do obtain the customer's consent via email prior to posting the testimonials and videos to post their name along with their testimonials and videos. To request removal of your personal information or video from our site, contact us at information@Redstone.edu. In some cases, we may not be able to remove your personal information, in which case we will let you know if we are unable to do so and why.

Job Applications

When using our job application page(s), these pages are hosted by our third party service provider. The information we collect on these pages is name, email, phone number, work history, certificates, work licenses that you have obtained, and education. We will also collect the name and email address of your references. All information collected on these pages is covered by the Alta Colleges privacy policy. Our service provider has no access or control over this information, they are simply hosting the pages on our behalf. We use this information to contact you if we determine that you are eligible for the job you have applied for.

Information collected automatically

In addition to the information you provide to us when you request information, we may automatically collect information about you that is not personally identifiable. Examples of this type of information include:

- Your Internet browser.
- Your IP address.
- Your computer's operating system.
- Your navigation path, including the domain name of the website that linked you to our site and which of our pages you visited.
- When you view one of our web sites, we may store cookies on your computer. These cookies allow us to tailor a web site or advertisement to better match your interests and preferences.

With most Internet browsers you can block cookies, receive a warning about cookies, or erase all cookies from your hard drive. Please refer to your browser instructions or Help screen to learn more about these functions. We do not link the information we store in cookies to any personally identifiable information you submit while on our site.

- The use of cookies by our tracking utility company is not covered by our privacy policy. We do not have access or control over these cookies.
- Our third party tracking utility company employs a software technology called clear gifs (a.k.a. Web Beacons/Web Bugs), that helps us better manage content on our site by informing us what content is effective. Clear gifs are tiny graphics with a unique identifier, similar in function to cookies, and are used to track the online movements of Web users. In contrast to cookies, which are stored on a user's computer hard drive, clear gifs are embedded invisibly on Web pages and are about the size of the period at the end of this sentence. We do not tie the information gathered by clear gifs to our customers' personally identifiable information.
- Targeted or Behavioral Advertising:
Targeted advertising (also known as Behavioral Advertising) uses information collected on an individual's web browsing behavior such as the pages they have visited or the searches they have made. This information is then used to select which Alta College advertisement should be displayed to a particular individual on websites other than an Alta Colleges site. For example, if you have shown a preference for nursing while visiting Alta Colleges.com, you may be served an advertisement from Alta Colleges.com for nursing related programs when you visit a site other than Alta Colleges.com. The information collected is only linked to an anonymous cookie ID (alphanumeric number); it does not include any information that could be linked back to a particular person, such as their name, address or credit card number. The information used for targeted advertising either comes from an Alta Colleges site or through third party website publishers. - Web Analytics Tools:
Our web sites use Google Analytics and Yahoo! Web Analytics to analyze web site use and activity. These tools use web-beacons and cookies to capture data about visitors to the web site. Your web browser sends this data to Google and/or Yahoo! as part of your interaction with the web site. The data typically includes the time spent viewing the website and any links or images on these pages that are clicked on. The cookies used by Google and/or Yahoo! contain no personal details such as your name, age or telephone number. Google and/or Yahoo! may also transfer this information to third parties where required to do so by law. Links to Other Sites

If you click on a link to a third party site, you will leave the Alta Colleges site you are visiting and be redirected to the site you selected. Because we cannot control the activities of third parties, we cannot accept responsibility for any use of your personally identifiable information by such third parties, and we cannot guarantee that they will adhere to the same privacy practices as Alta Colleges. How We Respond to Browser "Do Not Track" Signals:
